**Scope and Content Note:**

The materials in FOIA 2003-0372-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2003-0372-F contains materials from agencies and individuals from the White House Office of Records Management (WHORM) and White House Staff and Office Files. The WHORM Subject File categories contain correspondence, memoranda, news clippings, and brochures from the Bush administration. Most of these files contain presidential trip information and invitations from the Aspen Institute regarding the Aspen Institute Fortieth Anniversary Symposium in 1990, in which President Bush and Great Britain's Prime Minister Margaret Thatcher held meetings. The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. The files in the White House Advance Office contain schedules and trip information regarding the president's trip to Aspen, Colorado. The National Security Council (NSC) Files contain talking points and briefing papers regarding the president's meeting with Prime Minister Margaret Thatcher. A majority of the NSC files are closed due to national security issues.
