Bush to be Judge of the Fourth Circuit Court of Appeals on April 23, 1991 and confirmed by the Senate on July 26, 1991. 2005-1620-F 2 The White House Office of Records Management (WHORM) Alphabetical Files contain the resume of J. Michael Luttig dated 1989. The WHORM Subject File categories contain forms, memoranda, notes, and papers. These materials consist of papers analyzing legislation and correspondence regarding legal opinions from Luttig in his capacity as Assistant Attorney General on a variety of subjects, including allocation of expenses on political trips, recess appointments and nominations, nomination technicalities, legality of government actions, conflicts of interest, and the Hatch Act. The Staff and Office Files contain forms, memoranda, notes, and resumes that consist of personnel files of J. Michael Luttig, including his appointment as Assistant Attorney General and as a Member of the President's Commission on the Federal Appointment Process.
