**Scope and Content Note:**

The materials in FOIA 2008-0067-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2008-0067-F consists of letters of correspondence, memoranda, handwritten notes, biographical sketches, resumes, White House gift unit annual reports, and publications. The letters of correspondence are primarily from Congressional officials recommending that the White House consider various individuals as candidates for various executive boards, commissions, and executive branch positions. 2008-0067-F 1 Handwritten notes and memoranda are routinely exchanged among White House Offices for the purpose of informing or inquiring about potential candidates being recommended for various boards, commissions, and other executive branch positions. Resumes and publications are related to Constance Horner and present background information regarding her qualifications and abilities for successfully serving in a variety of positions within the executive branch. The White House gift unit reports provide lists of gifts given to and reported to the White House by Mrs. Horner while she served as the Assistant to the President and Director of Presidential Personnel from 1991-93.
