The White House Office of Records Management (WHORM) Alphabetical Files contain letters between George Romney and President Bush and his staffers regarding the establishment of the Points of Light Foundation, its merger with Romney's National Volunteer Center, and the appointment of Romney to the organization's board. The WHORM Subject File categories and Staff and Office Files contain correspondence, press releases, and personnel files related to the establishment of the Points of Light Foundation and Romney's appointment to the Commission on National and Community Service. Also included is correspondence and memoranda related to the appointment of Ronna Romney (Governor Romney's daughter-in-law) to the National Advisory Council on Adult Education.
