**Scope and Content Note:**

The materials in FOIA 2011-0284-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. 2011-0284-F 2 FOIA 2011-0284-F contains material from the Conventional Forces Europe (CFE) Chronological Files of Heather Wilson, a Director for Defense Policy and Arms Control on the National Security Council during the George H.W. Bush Administration. At this time the majority of the records in this request are security classified and have been closed under the restrictions of the Freedom of Information Act. The open records consist of articles, cables, fact sheets, lists, and memoranda. The articles contain an assortment of editorials on the North Atlantic Treaty Organization (NATO), International News summary of articles, and a transcript of ABC World News Report story on German Disarmament Proposal. The unclassified cables concern the Conventional Forces Europe (CFE) Joint Press Conference, Western Press Statement, text of speech delivered by CFE Ambassador Woolsey, and a Manfred Woerner interview on the CFE. Fact sheets include a press release fact sheet on CFE/NATO Proposal, NATO's Conventional Forces Initiative, and proposed press guidance on CFE. The lists include participants in a presidential meeting with Ambassador Woolsey, and a chronology of key events 1988-1989. Memoranda includes meeting notice memos, photo op and schedule proposal memos, routine transmittal memos and facsimile distribution sheets, and presidential memos commending the US Delegation for hard work on the CFE negotiations.
