The WHORM Subject File categories contain calendars, correspondence, press releases, and reports. There are schedules and calendars concerning weekly cabinet secretaries' activities. There are annual reports on the state of the Department of Veterans Affairs submitted by Secretary Derwinski. There is general correspondence between President Bush and Secretary Derwinski. There are press releases concerning the nomination of Secretary Derwinski. The Staff and Office Files contain correspondence, reports, and press releases. There is general information concerning the nomination of Edward Derwinski to the position of cabinet secretary. Also included in these files is his resignation letter. There is also included an official biography and photo.
