The materials in FOIA 2018-0722-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2018-0722-F contains materials from agencies and individuals concerning issues related to Japan and Puerto Rico. The White House Office of Records Management (WHORM) Alphabetical Files contain letters from the general public concerning personal issues related to taxes and employment. The WHORM Subject File categories contain correspondence from the general public, Congress, and the Bush administration. Documents include biographies of the members of the Presidential Task Force on U.S. Government International Broadcasting. Other documents include a letter requesting a testimony before a Congressional sub-committee and a note from President Bush to Michael Mansfield. The Staff and Office File contains correspondence from Michael Mansfield. The George Bush Vice Presidential Subject File contains an invitation to celebrate Ambassador Mansfield's birthday. The George Bush Vice Presidential Staff and Office Files contain briefing information for a trip to Puerto Rico in 1985 and letters from Puerto Rican Republicans.
