The Presidential WHORM Subject File contains general correspondence and unsolicited advice from Mr. Weinberger in his capacity as publisher of Forbes Magazine and Chairman of the USA-ROC Economic Council. The Vice Presidential WHORM Subject File contains correspondence between Vice President Bush and Caspar Weinberger in his capacity 1999-0099-F 1 as Secretary of Defense. The bulk of this material consists of invitations to various military events sponsored by the Department of Defense. The Presidential Staff and Office Files contain information on President Bush's pardon of Caspar Weinberger and background material on Iran-Contra including indictments, testimony, and newspaper articles. The Staff and Office Files also contain information on Caspar Weinberger's personal papers and a discussion of access to those papers by Independent Council Lawrence Walsh.
