The materials in FOIA 1999-0731-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 1999-0731-F contains of the files of William Butterfield, an associate director in the Office of Cabinet Affairs. Butterfield maintained responsibility for preparing disaster related documents including correspondence regarding major disaster declaration approvals or denials. In addition to 1999-0731-F 1 standard letters and memoranda are reports detailing the effects of a particular disaster on a given area. The files also contain materials relating to the Office of Personal Management and the granting of Presidential quality management awards. Most of the materials date from 1992.
