Scope and Content Note:

The materials in FOIA 2010-0790-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2010-0790-F contains materials from agencies and individuals including the Administration Office, the Domestic Policy Office and Council on Competitiveness, and Mrs. Quayle's Office. Records responsive to this request are related to the White House Fellows Program, its candidates and participants. The Staff and Office Files contain memoranda, resumes, applications, pamphlets, letters, articles, invitations, and guest lists. Correspondence includes inter-office communications concerning the White House Fellows Program applicants and the placement of new fellows within the Bush Administration. Documents related to the backgrounds of fellows - including personal, professional, and educational - are included. Because the application process to the program was both lengthy and detailed, files on individuals can be quite large. Often, applicants included copies of articles with their applications that either highlighted the applicants or were written by them. White House Fellowship pamphlets are included in the material. The invitations and guest lists are for a social coffee hosted by Mrs. Quayle for Fellows' spouses.
