



## [Records on Jon Huntsman Jr.](#)

**Scope and Content Note:**

The materials in FOIA 2011-1037-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2011-1037-F contains materials on the subject of Jon Huntsman Jr. from agencies, individuals, and said person, who was Deputy Assistant Secretary of Commerce, Trade Development Bureau, International Trade Administration, 1989-1990, Deputy Assistant Secretary of Commerce for East Asia and the Pacific, 1990-1991, and Ambassador to Singapore, 1992. The collection primarily documents 2011-1037-F 2 Huntsman's progression towards the aforementioned positions and similarly contains forms, letters, and biographical information regarding him. The papers are from the George Bush Presidential and Vice Presidential Records. The White House Office of Records Management (WHORM) Alphabetical Files contain letters of correspondence, forms, biographical sketches, memoranda, publications of Jon Huntsman, Huntsman Chemical Corporation, and Singapore from individuals and agencies concerning Jon Huntsman Jr. Letters include communication between Mr. Huntsman and George Bush, Jennifer Fitzgerald, Executive Assistant to the Vice President, and Craig Fuller, Chief of Staff. The WHORM Subject File categories contain memoranda, biographical sketches, and a press release, all from individuals regarding Jon Huntsman Jr. These materials include consideration of Jon Huntsman Jr. for the position of Ambassador to Armenia and for the position of Ambassador to Singapore. One memorandum is in regards to the Huntsman family's contribution of money to the University of Utah, along with a news article and biographical sketch of Mr. Huntsman. A press release related to Jon Huntsman Jr.'s nomination of Ambassador to Singapore is also included. The Staff and Office Files contain letters of correspondence, memoranda, forms, reports, foreign travel notifications, biographical sketches of Jon Huntsman Jr., published materials, personnel selections, and press releases maintained by individual staff members and offices regarding Jon Huntsman Jr.'s travel, interviews, consideration and nomination for Ambassador to Singapore.
