FOIA 2011-2567-F contains materials from agencies and individuals including Alan Greenspan, the Board of Governors of the Federal Reserve System, George H.W. Bush, and the Council of Economic Advisors. The White House Office of Records Management (WHORM) Alphabetical Files contain Recommendation Routing Ticket forms; letters from constituents both supporting and opposing the reappointment of Alan 2011-2567-F 2 Greenspan as Chairman of the Federal Reserve Board; routine correspondence from Greenspan and/or his office asking for photographs to be inscribed, passing along information, and recommending individuals for appointment to office. The Staff and Office Files contain copies of newspaper articles regarding the economy; charts of economic data; informational memos discussing economic issues; economic policy newsletters from the private sector; public press briefings regarding a variety of issues; and reports on economic issues. The Office of Vice President Bush Name files and Vice Presidential Staff and Office Files and consist of Speaking Request forms for a meeting with Greenspan; letters from Bush to Greenspan recommending personnel appointments; and thank you notes between Bush and Greenspan.
