Scope and Content Note:

The materials in FOIA 2014-1250-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2014-1250-F contains materials from agencies and individuals including President and Mrs. Bush, Pearl Mae Bailey, Louie Bellson, and the United Service Organization (USO) which is a private non-profit with the mission to support the troops. The president of the USO at the time was Charles Hagel. The White House Office of Records Management (WHORM) Alphabetical Files contain photographs and letters between Pearl Bailey and Mrs. Bush. The WHORM Subject File categories contain correspondence; memoranda; gift registers; notes; and photographs from the general public and the Bush administration. WHORM Subject File GI002 concerns gifts and cards sent to the President and Mrs. Bush by Pearl Bailey. WHORM Subject File ME002 contains material related to the presidential message for the USO's 50 th anniversary celebration which honored Pearl Bailey. WHORM Subject File PP005-01 contains correspondence between Mr. Louie Bellson and Mrs. Bush after the passing of Pearl Bailey. The Staff and Office Files contain memoranda, speech drafts, press releases, questionnaires, and rÃ©sumÃ©s concerning the appointment of Pearl Mae Bailey as a US Representative to the 44 th Session of the General Assembly of the United Nations.
