Scope and Content Note:

FOIA 2015-0242-F contains materials from agencies and individuals regarding the rendition of Dr. Humberto Alvarez Machain from Mexico on April 30, 1990 and executive, legislative and judicial stance on the topic of rendition in general. This collection contains correspondence, memoranda, letters, newspaper articles, press guidance memoranda, press releases, Department of Justice decisions, and Supreme Court decisions. Letters and memoranda primarily consist of correspondence between executive agencies, Congress and the Department of Justice discussing and sharing publicly acknowledged United States policy on the rendition of Dr. Humberto Alvarez Machain. Newspaper articles are of media coverage debating legal authority of the United States to arrest fugitives and traffickers associated with international drug trade. Administrative press guidance and releases communicate to the general public United States policy and stance regarding the topic of rendition. Department of Justice statements and Supreme Court decisions dictate U.S. legislative authorities regarding the topic of rendition.
