Scope and Content Note:

The materials in FOIA 2015-0655-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. FOIA 2015-0655-F contains materials related to transportation issues during Bush's Vice Presidential and Presidential terms of office. The Bush Presidential WHORM Subject File category contains White House Correspondence Tracking Worksheets, letters and biographies. These documents pertain to the appointments of John W. Snow and John G. Roach to the National Commission on Intermodal Transportation. The Bush Presidential Staff and Office Files contain memos, questionnaires, clearance requests, biographies, personal data statements, news releases and guidance related to appointments of personnel to the National Commission on Intermodal Transportation. Information on enrolled bills describe the purpose of legislation addressing highway funding, programs, safety, and airport authorities. Presidential statements and press releases announce approval of this legislation in addition to key legal features. The Bush Vice Presidential WHORM Subject Files contain Vice Presidential Correspondence Tracking Worksheets, letters, Scheduling File Tracking Sheets, Vice Presidential Activity memos, scheduling requests, invitations extended to Vice President Bush and replies, a transportation conference schedule, and an exhibit program.
