Scope and Content Note:

The materials in FOIA 2019-1043-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2019-1043-F contains materials from agencies and individuals including U.S. Mission to the United Nations. The WHORM Subject File categories contain correspondence to the White House concerning the U.S. role in UN Peacekeeping missions. The Staff and Office Files contain cables, memos, papers, and reports. The declassified and unclassified cables contain news articles as well as general instructions to the American Mission to the United Nations concerning peacekeeping issues. There are also declassified and unclassified memos and papers concerning topics such as participation and funding along with long term costs of participating in peacekeeping and humanitarian efforts, humanitarian relief issues, 1993 Report to Congress on Proposed Refugee Admissions for FY 1993, and copies of the UN Secretary General's report "An Agenda for Peace," as well as copies of administration officials' testimonies before Congress concerning peacekeeping. There are also copies of President Bush's 1992 address to the General Assembly concerning peacekeeping. There are also letters from Congress and interest groups related to US involvement in peacekeeping activities.
