The materials in FOIA 2021-0175-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Correspondence from the postal service includes an invitation to President Bush to attend a postal union ceremony and a request for self-representation in litigation regarding new postal rates/fees. Other correspondence relates to commemorative stamps and recommendations for appointment to the postal rate commission. The reports discuss stamp subject criteria and administrative information about the postal rate commission, such as organization and statutory authority for the commission, pending issues, budget estimates, and commission personnel. The federal records consist of correspondence from the Postal Rate Commission about pre-printed courtesy envelope, National Consumers Week, and the Consumer's Resource Handbook.
