Scope and Content Note:

The materials in FOIA 2023-1282-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2023-1282-F contains materials related to the Caribbean island nation of Haiti. The White House Office of Records Management (WHORM) Alphabetical Files contain correspondence from private citizens, U.S. businesses, and local governments voicing opposition to the economic embargo enacted against Haiti by the United States. Also included are various resolutions issued by city and state governments. The WHORM Subject File categories contain similar correspondence as that found in the WHORM Alphabetical Files as well as presidential remarks and executive orders related to the extension of the emergency related to the 1991 Haiti coup. The Staff and Office Files consist of materials of a similar vein to those in the WHORM Subject and Alphabetical files, as well as schedules, planning, and logistical materials related to Vice President Quayle's trip Haiti and the South American countries of Bolivia, Colombia, and Peru.
