The WHORM Subject File categories contain correspondence from child welfare organizations concerning the issues of paternity and child support. The Staff and Office Files consist of correspondence, memoranda, and publications maintained by individual staff members and offices. These records include a number of government and private sector generated reports, including copies of testimony and statements given by government officials before the Ways and Means Subcommittee on Human Resources.
