The White House Office of Records Management (WHORM) Alphabetical Files contain correspondence from Reverend Sun Myung Moon and private citizens requesting a pardon for his conviction for failure to pay federal taxes. The WHORM Subject File categories contain correspondence from Unification Church members seeking a pardon for Rev. Moon and memoranda and correspondence pertaining to a letter purported to be from Vice President Bush to Unification Church Member and editor of "Insight on the News" magazine Bo Hi Pak that was featured on the news magazine program "Frontline". The Staff and Office Files contain materials similar to those above in addition to correspondence and memoranda related to a presidential greeting for a meeting of the World Anti-Communist League.
